### 1. Introduction

### 2. Information We Collect

#### 6. Sharing of Information

We may share personal information only as necessary with:

- Trusted subcontractors or partners involved in estimating, scheduling, installation, or service fulfillment
- Service providers that support our communications, customer management, or business operations (including SMS and email platforms)

We **do not sell or rent** personal information to unaffiliated third parties for independent marketing purposes.

- Personal information will **NOT** be shared for marketing purposes.
